## **Executive Summary**

 The purpose of this presentation is to discuss the proposed use of \$2,487,500.00 in proceeds to be received from the Easement Agreement For C Deck as executed by the CityPlace Community Development District on May 8<sup>th</sup>, 2023. CityPlace Retail LLC proposes these funds be utilized for required garage repairs which are currently in-process for the A, B, and D garages.

#### **Ownership Summary:**

**FRELATED** 

- A & D Garages: CDD air-rights / ground lease through 2026
- B Garage: CDD air-rights / ground lease through 2046
- C Garage: CityPlace Retail LLC executed exclusive easement for exclusive use of C Garage through 2046 for ~\$2.5MM



### Garage Assessment & The Proposed Project

- In 2022, Alanna Buick and Bers ("AB & B"; waterproofing consultant) + Frank W. Neal & Associates ("FWN & A"; structural engineer consultant) conducted an assessment of the A, B, C, and D garages followed by a proposed set of project specifications and scope of work.
- The Proposed Project' Budget of **\$3,650,000.00** includes the following scope across the A, B, and D garages:
  - Structural remediation and restoration to make repairs to various structural connecting points
  - Repairing spalling concrete
  - Replacing failed caulking
  - Installing new expansion materials
  - Adding drains
  - Retrofitting LED lighting (<u>A & D Only</u>)
  - Painting (<u>D Only</u>)
  - Electrical maintenance (D Only)
  - New elevator lobby lights (<u>D Only</u>)
  - Exit signs (<u>D Only</u>)
